

## AFFIDAVIT OF ELIGIBILITY/LIABILITY & PUBLICITY RELEASE

### The Parsha Trivia Contest (the “Contest”)

4. I further represent that to my knowledge my child/ward has won and will receive only one prize from this Contest.

I understand that neither the Sponsors nor their subsidiaries, affiliates, agents, assigns, or any entity connected with this Contest will be responsible for any costs (including, without limitation, any federal, state or local taxes) I may incur in connection with this Contest or any prize that my child/ward may be awarded.

I hereby grant to Sponsors and their assigns the absolute right and permission to use my child/ward’s Contest submission, as well as my child/ward’s name, image, voice, photograph, and/or other likeness of my child/ward, and our home city and state, in any and all advertising and promotional materials, or to refrain from doing so, in any manner or media whatsoever, including on-line, worldwide, in perpetuity for advertising and promotional purposes in conjunction with this and similar promotions and/or for general advertising and promotional purposes without notice to me and without further compensation. To the extent permitted by applicable law, I hereby waive all claims, release, hold harmless and indemnify the Sponsors and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotional agencies, assignees, licensees, attorneys, representatives and prize suppliers, and each of their respective parent, subsidiary and related companies (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Contest or receipt, use or misuse of any prize awarded herein.

**It is understood and agreed that this is a complete RELEASE and DISCHARGE of all claims and rights of the undersigned against the Sponsors and that no action will be taken by or on behalf of the undersigned with respect to any such rights, it being understood that this release shall be binding upon the heirs, executors, and administrators of the undersigned.**
